

Update from Bristol Council's Culture and Creative Industries Team May 2020

We continue to do all we can to understand and address the challenges being faced by Cultural and Creative Industries organisations, microbusinesses, sole traders and freelancers across Bristol.

Thank you to all of you who have found the time to complete our recent sector surveys; your responses, along with findings from Arts Council England, Creative England, and Film Offices around the country are helping make the case to DCMS at the Parliamentary Committee on 16 June. They will also inform our plans for how we as a service can support the sector in Bristol.

Details are still emerging about the relaxing of Covid-19 Lockdown measures following on from the National Government announcement. The government has set five task forces to focus on particular areas; one of which will focus on Tourism, Hospitality, Leisure, Sport and Culture, led by the Department for Culture, Media and Sport. Further details can be found here.

We are now in Phase 3 of Lockdown relaxation measures, which effects Culture and Creative Industries including our own Bristol Museums, alongside Bristol Libraries. This will mean transitioning safely back to opening up buildings, sites, locations, as possible within social distancing measures and latest guidelines, from July. Earliest we can re-open is from 4 July but all dates are to be confirmed.

Finally, many creative businesses and freelancers have already made use of Bristol Council's new Outset micro-business COVID-19 support programme which is designed to help small businesses (10 employees or less) navigate the current crisis and think about both recovery and business development. The programme is on offer until end of June.

New grant funding

Small Business Grants Discretionary Fund

New government fund developed by Bristol Council in collaboration with other West of England local authorities. Eligible businesses include small businesses in shared offices, regular market or street

traders, bed and breakfasts and charity properties receiving charitable business rates. Grants up to £5,000. **Apply by Mon 8 June (midnight)**.

Gane Trust Hardship Fund

The Gane Trust in partnership with Tobacco Factory Theatres and The Cube Microplex are inviting applications from artists and arts-workers living in the Bristol area who are currently experiencing financial hardship due to Covid-19. Grants up to £500. **Apply by Tues 9 June.**

Events 2020

Based on current government advice, an Autumn 2020 calendar for Bristol events and festivals is in process. Proposed dates will come with a number of caveats around adhering to, and adapting to, latest government guidance and the interest of public health and safety.

Events 2021

The Site Permissions Team are in the process of contacting the organisers of returning events for 2021. Please note these will depend on latest government guidance. Filming & TV Production update

Bristol Film Office (BFO) is working with Creative England and Film Offices across the UK to develop a uniform approach to managing public health and safety on location, and enable filming activity to restart. We are using national industry guidance for managing COVID-19 to influence local filming codes of practice and production insurance requirements and expect these to be in place by mid-June 2020.

We continue to work closely with The Bottle Yard Studios to advise and support production companies and enable filming to take place in Bristol. Together, we are expecting the production industry to be one of the first to resume work, albeit with new and strict working practices in place. Over the coming weeks BFO will continue to consult with Producers, Location Managers and other production personnel to find ways to meet production requirements whilst prioritising public health and safety.
